For now VGK will operate between the hours of 11:00 a.m. - 2:00 p.m. A small breakfast menu with fresh juices will open this summer. For lunch,

soups will be served hot to go, or in recyclable mason jars to take home for a fast, healthy dinner. Vintage Garden Kitchen will offer jarred soup delivery within Place St. Charles and eventually to other office buildings nearby. Lunch catering will follow sometime this summer.

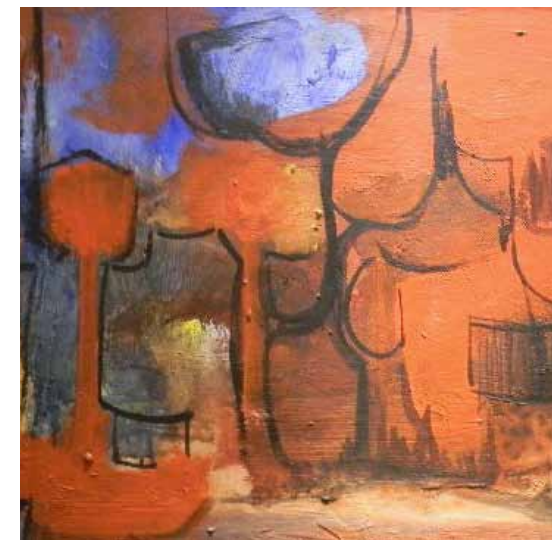
